The course was organized into two parts; I taught the first part, or ten lessons (thirty hours), in Italian. I first treated such topics as: classical and recent approaches to international relations (realism, liberalism, and constructivism; post-paradigmatic debates). Then I focused on strategic studies: mobilization plans during World War I, nuclear proliferation (with a focus on Iran), and the military aspects of the China-US confrontation.

- Adjunct professor, Department of Political and Social Sciences, University of Bologna (2016-2021).

As a part of the course in "International Conflicts" (in Italian; 60 hours, 10 credits) I have treated such topics as: international crises; deterrence, compellence, and coercive diplomacy; game theory; structural realist theories and power-transition theory; the bargaining model of war; psychological theories of international relations; selection effects and deterrence; a wide review of the literature on the audience costs; civil and ethnic wars; terrorism; gender and the evolutionary roots of human violence; genocide. I have taught this course from the Fall 2016 to the Fall 2020.

I have also taught an MA course that covers the basics of international relations: "Crash Course in International Politics" (in English, 20 hours, no credits). Topics treated include: classical IR theories (realism, liberal institutionalism, the English School, constructivism) as well as the debate on the democratic peace, psychological theories of IR, and a brief introduction to the bargaining model of war. I have conducted this course in 2016/17 and 2018/19.

I have taught a course on "International Relations" (in English, blended), 60 hours, 30 in class and 30 online. The online part was supervised by the tutor, M. Dian. Some of the topics that I have treated in class include: Pearson's rationalist explanations for war; psychological theories of international relations; structural realism and the split between defensive and offensive realism; democratic peace theory; explanations of, as well as a review of the criticisms to, democratic peace theory; constructivist theories; civil wars; commitment problem in civil wars; international institutions; introduction to game theory; cooperation in a repeated prisoner's dilemma; power transitions; self-selection and economic sanctions.

I have taught a course on Global Politics (40 hours, in English; 8 credits) and a course on Local Politics and Welfare (30 hours, in Italian; 6 credits). The course on Global Politics follows rather closely the arguments that I have taught in my previous courses at the University of Bologna. As a part of my course on Local Politics and Welfare, I have treated such topics as: amoral familism, clientelism, corruption, social capital, pluralism (Dahl) vs. elitism, the three types of welfare state, the fourth model of welfare state in Southern Europe, urban politics, civil strife and protests.
